AAOMP and CAP Discuss Common Goals

The College of American Pathologists (CAP) and the AAOMP hope to work more closely together on mutual interests, reestablishing an affiliation that lapsed in recent years.

The new potential affiliation was discussed during a conference call between the officers and executives of the two organizations on July 13th, which AAOMP President John Fantasia called “a very positive interchange” and Past-President Mike Rohrer described as “extremely cordial and cooperative”.

According to Dr Fantasia, “The goal of such an affiliation would be to support the efforts of CAP related to regulatory, compliance and reimbursement issues. Such a working relationship could help our common goals.”

AAOMP hopes to participate in CAP’s annual Washington seminar in January, which focuses on legislative issues and lobbying efforts that impact the pathology profession. AAOMP might also participate in CAP’s annual continuing education program. Dr Fantasia says, “Working with their Surgical Pathology Committee as an affiliate was also suggested.

I have written a letter to the President of CAP, requesting an affiliation that would allow AAOMP to be invited to the aforementioned sessions. This request will be presented to CAP’s Board of Governors in the next few months.”

Commenting on the importance of the potential strengthened ties, Dr Fantasia said “CAP has affiliations with various pathology organizations, and they recognize that the more voices in support of various initiatives the more likely the goals will be achieved. They are aware we have the respect of our medical colleagues that we interact with on a regular basis.”

Dr Rohrer and CAP Executive Vice President Nikki Norris initiated contact between the two organizations. Dr Fantasia and Thomas Sode-man MD, current president of CAP, followed this up with further preliminary discussions leading to the recent conference call.

Another successful meeting

The continuing education program and CPC sessions were also highly regarded based on session evaluations. Special thanks to John Hellstein and the CE committee for their efforts related to the Symposium and Continued Competency Assurance Program. Both continue to grow in popularity and along with the regular course offerings represent AAOMP's main source of revenue. Memberships continued participation in these programs is appreciated and encouraged.

Valerie Murrah put together an enthusiastic group of contributors and discussants for the CPC program, with some extremely challenging cases; I am sure all recognize the effort of those involved. The Founders seminar was well received with Dr Stelow giving an informative overview of cytopathology.

A special thanks to Mike Rohrer, who was ultimately responsible for the success of the meeting. Mike as well as Mike Kahn, Jan Handlers and Ray Melrose helped defray the meeting costs by securing significant commercial sponsorship, recognizing that this is needed for an organization such as ours to succeed. Mike and Cecilia Rohrer were truly gracious hosts who have the knack of making everyone feel special and welcomed. Mike is the consummate family man and transmits this attribute to the oral pathology family with sincerity. We discovered he is a comedian as well. I have learned much from him, and will always be the student. Bruce Barker could not control the rain, although we were led to believe otherwise, but he did provide us with a montage of memorable AAOMP meeting photographs of years past. This was nostalgic for most and I am sure humorous as well. Oral pathologists are a motley crew, at least in front of a camera lens. The UMKC jazz band was outstanding and certainly embodied the spirit of Kansas City, as Bruce predicted. Janet and Liz, with Mike Kahn always on the ready, did their usual fine job of keeping registrants, lecturers, sponsors, coffee breaks, business meetings, breakfasts, luncheons, banquets and so much more all coordinated.

Stronger relations with other specialties and the ADA

There have been exciting new developments in forging stronger ties between the College of American Pathologists and the AAOMP. These are outlined in the cover story of this newsletter.

Drs. Murrah, Zunt and I attended the July meeting of the Dental Specialty Groups in Chicago. It is important to strengthen the specialties influence, speak as a unified voice on issues of mutual interest with the ADA, and to work on initiatives that are of benefit to the public and the profession. We have suggested that all of the specialties add links to the other recognized specialties on their individual websites. The Group also heard presentations from ADEA President James Swift regarding their initiative with the Academy for Academic Leadership to recruit and develop new dental faculty. At the DSG meeting AAOMS presented consideration of having residency programs reviewed and accredited by the American College of Graduate Medical Education (ACGME). The president of ACGME gave an overview of the structure and policies that govern the ACGME.

The ADA's Council on Scientific affairs will be hosting an expert panel workshop on oral cancer screening, Chicago, Oct 31, Nov 1, 2, 2007. AAOMP has been invited to send a representative, and I have asked John Kalmar who has agreed to attend. Mark Lingen, as a representative on the Council of Scientific Affairs will also attend. AAOMP will have a strong voice in this workshop. It will focus on clinical recommendations based on analysis of evidence presented in published systematic reviews. Mark Lingen, John Kalmar, Paul Speight and Ted Karrison, have just completed a review of such and their work has been accepted for publication; so they have an extremely good handle on the evidence as it stands.

We have written to the ADA Committee on the New Dentist, indicating AAOMP's willingness and desire to participate in these annual sessions. Addressing clinical topics of interest to the New Dentist, and how best to use the services of our specialty would be timely and helpful to this select group.

John Sauk, on behalf of AAOMP, attended an NIH Consultation Meeting on Peer Review with Professional Societies. The purpose of this meeting was to seek input from societies, to offer specific strategies or tactics for enhancing NIH peer review and research support. Congratulations to John on his appointment as Dean, School of Dental Medicine, University of Louisville. John joins the Dean ranks with fellow oral pathologists, Catherine Flaitz, Lawrence Goldblatt, Peter Polverini, and Stephen Young.

Mike Kahn and I will be attending the ADA Recognized Dental Certifying Boards and Organizations meeting. Steve Young is Chair, Council on Dental Education and Licensure and will be presiding at this meeting. This will give us an opportunity to interact with the ADA President and President-elect among others. Harvey Kessler and Craig Fowler will be representing the ABOMP. An upcoming symposium on Integrity and Ethics in Dental Education is on the agenda. John Wright, oral pathology's CODA representative has also informed us that CODA too will be discussing ethics as an educational mandate, potentially incorporating such into the standards. CODA on July 26, 2007, approved proposed revisions to the accreditation standards for Oral and Maxillofacial Pathology. John Wright asked for input from Program Directors, prior to the revisions being made, and it is felt that the revised standards better define program objectives and content.

The Code Revision Subcommittee of the Council on Dental Benefits Program meeting of August 9, 10 was attended by Mike Kahn. This also included the preceding dental specialties organizations meeting with the ADA members of the committee and a post-code meeting among the specialty organizations.

AAOMP will be represented at the Annual ADA meeting in San Francisco, we will be present at the House of Delegates meeting, and will have an informal gathering of any of our members in attendance at the Fairmont Hotel, early Friday evening, September 28th. If any of you plan on attending the ADA session and would like to meet, drop me an e-mail. John Hellstein and John Kalmar have been invited to give a presentation on Bisphosphonate-related Osteonecrosis of the Jaws at the ADA annual session.

Save the Date: IAOP/AAOMP Meeting

While vacationing in San Francisco in June, I met with Janet Svazas and Richard Jordan at the Fairmont, Nob Hill. The hotel's representative, Philip Chang, gave us a walk through the hotel and meeting facilities. This is a spectacular setting for the upcoming joint IAOP/AAOMP meeting June 22 – 26, 2008. The hotel offers the best of the old and new. There have been extensive restoration and renovations to this landmark hotel, preserving the historical features it is known for. 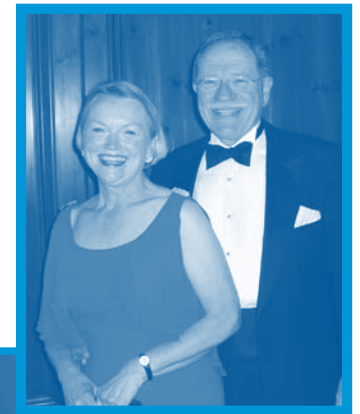

IN MEMORIAM

DR. RODERICK CAWSON • Prof RA Cawson died on 25 April 2007. Professor Roderick Cawson MD, FDS RCS, FDS RCPS, FRCPath was Professor Oral Medicine and Pathology at Guy's Hospital Dental School, London UK from 1966-86 and Emeritus Professor since retirement. He qualified in medicine and dentistry and obtained his MD from King's College, London. He served in the British Royal Air Force 1944-8. He published many well-known research papers. He held an international reputation for excellence in salivary gland pathology and was a member of the UK Salivary Gland Pathology panel. He will perhaps be best known as a prolific author of textbooks with at least 10 books to his name, many in multiple editions. He submitted his last manuscript only a few months before his death, and was working on another when he died. He will be remembered by all those who met him as an enthusiastic and sometimes acerbic teacher with an encyclopedic knowledge of medicine, dentistry, pharmacology and therapeutics. He continued teaching postgraduates for many years after retirement and held visiting professorships including Baylor College of Dentistry, Texas. He had many contacts in the AAOMP, and hosted many colleagues from all over the world in his department over the years. He is survived by his wife Diana Cawson.
